LAST WILL AND TESTAMENT
Of

I, **RAYMOND E. ZIEGLER** of Skamania County , State of Washington, do hereby declare this to be my Last Will and Testament. I do hereby revoke any and all Wills and Codicils executed by me prior to the date of this instrument.

ARTICLE I.

Identification of family

I declare that I am a single person and that I have had four children born to me who are my late son Jerry who has predeceased me leaving Keven Ziegler, Alicia Burns, Tammy Rike and Stephanie Ziegler and my son Raymond, Jr. who left surviving him Vickie Still and Glen Ziegler. I have two living children who are Patricia Sanford and Louraine McGrew.

ARTICLE II.

Personal Representative

I do hereby appoint my daughter Louraine of Goldendale, Washington to serve as the personal representative of my estate and I do direct that she serve without bond and without the intervention of any court except to the minimum extent required by law.

ARTICLE III.

Debts and Estate Expenses

I hereby order and direct that all my just debts for which proper claims are filed against my estate and expenses of its administration shall be paid from my estate by my personal representative as soon after my

death as is practicable, PROVIDED HOWEVER, that this direction shall not authorize any creditor to require payment of any debt or obligation prior to its normal maturity in due course.

ARTICLE IV.

Disposition of Estate

Upon my death I hereby give, devise and bequeath to my children and grandchildren above named, all of the rest residue and remainder of my estate of every kind and nature whatsoever and wheresoever situated, to share by right of representation.

ARTICLE V.

Burial Instructions

I direct that upon my death my body be disposed of under the direction of my personal representative but without undue cost or expense.
