Signatures of the owners must be interested or certified by the selling dealer or a vehicle licensing agent. Fees will include a filling and application lee plus sales or use tax due. Additional fees may include: a little elimination fee and a Mobile Home Affairs Fee. Subagents will charge an additional service fee. (Fees are subject to change without notice.)
- SECTION 4 Take the properly completed Manufactured Home Application and all necessary supporting documents to the County Auditor/Licensing Agent Office for approval. Supporting occurrents may include but are not limited to: proof of ownership or a Manufacturer's Statement of Origin (MSO) proof of taxes paid, and applicable release(s) of interest. Subagents may not complete the approval portion of this form.
- SECTION 5 The "Title Company Cértification" box must be compléted when processing a "Transfer in Location" or a "Removal From Real Property" application. Important: The final recorded application form must be submitted to a vehicle licensing agent within 10 days of the title company's certification.
