- (14) To appoint and substitute for itself, agents or attorneys to perform any or all of the above duties and thereafter to revoke such authority as it deems advisable;
- (15) To execute and deliver deeds, checking accounts, savings accounts, credit union accounts, owner hip of policies of life insurance, time certificates of deposit, stock and bond powers, assignments of notes, mortgages, patents, contracts, deeds of trust, covenants, royalties, indentures and agreements, and any other asset, property right or thing of value, and to perform all and every act and thing whatsoever requisite and necessary to be done to transfer assets belonging to me to any person or corporation; and in furtherance thereof, my said attorney in fact is authorized to enter any safe deposit box in my name to remove and deliver the contents or any part thereof;
