

## Limited Power of Attorney

KNOW ALL MEN BY THESE PRESENTS, That JOHN V. GITTINS hereby ratifying and confirming all that the said attorney PEGGY L. HARDY shall lawfully do or cause to be done, by virtue of these presents, and this LIMITED POWER OF ATTORNEY shall continue until revoked in writing by JOHN V. GITTINS, or upon his death, whichever first occurs.
