I, CODY LOVELESS, now domiciled in Skamania County, Washington, being of legal age and of sound and disposing mind and memory, and not acting under fraud, undue influence or duress, do hereby make and declare this instrument to be my Last Will and Testament, hereby revoking any and all prior Wills and Codicils heretofore made by me.

I declare that I am a single person. I have never had nor adopted any children.

II

I appoint my good friend, RAYMOND ZIEGLER, of Skamania County, Washington, as my Personal Representative, with all of the power, authority and discretion herein given to my Personal Representative. In the event RAYMOND ZIEGLER shall be unable or unwilling to serve as Personal Representative, then I appoint ROBERT K. LEICK, Attorney at Law, to serve as contingent Personal Representative, with all the same powers and authority granted to my first-named Personal Representative.

I direct that no bond, surety or other security be required of my Personal Representative in any jurisdiction for any purpose, and that my Personal Representative shall have unrestricted non-intervention powers to settle my estate in the manner provided for in this Will. Furthermore, my Personal Representative shall, in carrying out the provisions of this Will and in otherwise administering my estate, have full power, authority, and discretion to do all that may to my Personal Representative seem necessary or desirable in administering my estate.

III

I direct that all estate, inheritance, and other taxes (and interest or penalties thereon) imposed by reason of my death, whether or not attributable to property passing under this Will, and whether or not the same would otherwise be payable by my estate or by any recipient of any such property, be paid and discharged by my Personal Representative out of the residue of my estate, with no right of reimbursement from the recipient of any property which does not pass thereunder.

IV

(A) Unto RAYMOND ZIEGLER, IN TRUST, for the benefit and care of my cat,

RECORDER'S NOTE:
NOT AN ORIGINAL DOCUMENT

"SPOT", I bequeath the sum of Five Thousand Dollars (\$5,000.00). It shall be in the sole discretion of RAYMOND ZIEGLER to use said Trust to serve the best interests of "SPOT" for so long as "SPOT" shall live. In the event "SPOT" should become deceased before the Trust is fully expended, the residue of the Trust shall become a part of the residue of my estate.

In the event RAYMOND ZIEGLER shall predecease me, or should we die in a common disaster, or he does not survive me by thirty (30) days, I nominate and appoint ROBERT K. LEICK, Attorney at Law, as contingent Trustee of the funds to provide for the care and best interests of "SPOT" for so long as "SPOT" shall live.

(B) The "residue of my estate," as that term is used in this Article, shall mean all of the property which I may own at the time of my death and which remain after payment of all claims, expenses, taxes, and other liabilities of my estate, after effect is given to the gifts for which provision is made in Article IV (A) above, and shall include all property of whatever nature and wherever situated, including all gifts made by this Will which shall fail for any reason.

I give the rest, residue and remainder of my estate, whether real, personal or mixed, and wheresoever situate, unto my good friend, RAYMOND ZIEGLER, as his sole and separate property if he survives me by thirty (30) days. In the event RAYMOND ZIEGLER shall predecease me, or should we die in a common disaster, or he does not survive me by thirty (30) days, then I give the rest, residue and remainder of my estate, whether real, personal or mixed, and wheresoever situate, unto THE SALVATION ARMY, A CALIFORNIA CORPORATION, with principal offices at 30840 Hawthorne Boulevard, Rancho Palos Verdes, California 90274, for use in its NORTHWEST DIVISION.

VI

The provisions of this instrument shall be governed by the laws of the State of Washington. Any provision which is prohibited by law or is unenforceable shall be inoperative, and all of the remaining provisions shall, nevertheless, be carried into effect.

VII

If any beneficiary shall contest the probate or validity of this Will or any provision thereof, or shall institute or join in (except as a party defendant) any proceedings to contest the validity of this Will or to prevent any provision thereof from being carried out in accordance with its terms, then all benefits provided for such beneficiary are revoked, and such benefits shall be distributed as if such beneficiary were not living. Each benefit conferred herein is made on the condition precedent that the beneficiary shall accept and agree to all provisions of this Will, and the provisions of this Article are an essential part of each and every benefit.
