NOTICE IS HEREBY GIVEN that CISPUS LOGGING, INC., a Washington corporation, of Lewis County, Washington, claims a lien upon Douglas Fir and Hemlock logs, being five (5) loads in quantity, which were cut or manufactured in Skamania County, State of Washington, are marked thus \_\_\_\_\_, and are now lying in Lewis County, Washington at Morton Forest Products, Inc., for labor performed upon and assistance rendered in harvesting said logs; that the name of the owner or reputed owner is Cispus Logging, Inc.

The said Morton Forest Products, Inc. agreed to pay the said Cispus Logging, Inc. for such labor and assistance in connection with said logs or timber; that said contract has been faithfully performed and fully complied with on the part of Cispus Logging, Inc. who performed labor upon and assisted in the harvesting and selling of said logs; that said labor and assistance were so performed and rendered upon said logs and timber between the 17th day of September, 1999 and the 21st day of September, 1999; and the rendition of said service was closed on the 21st day of September, 1999, and sixty (60) days have not elapsed since that time; that the amount of Claimant's demand for said service is Ten Thousand and 00/100 Dollars (\$10,000.00); that no part thereof has been paid except zero dollars, and there is now due and remaining unpaid thereon the sum of Ten Thousand and 00/100 Dollars (\$10,000.00). Said Cispus Logging, Inc. also claims a lien on all said lumber now owned by said Morton Forest Products, Inc. of said county to secure payment for the work and labor performed.

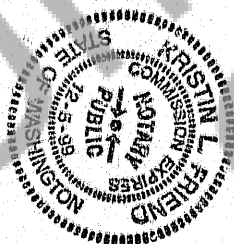
