This Indenture, made this 31st day of May, 1910, by and between Rebert C.Prindle and Louise A. Prindle, his wife, and E.H.Prindle and Frances C.Prindle, his wife, of the County of Skamania, State of Washington, hereinafter called the lessees, and the Washington Northern Railroad Company, an Oregon corporation, hereinafter called the lessee, Witnesseth: That in consideration of one dollar, the receipt of which is hereby acknowledged, and of the surrender and cancellation of a certain llease to E.J.Blazier, recorded in book two of lesses and agreements page 30 here; after faferred to, and of the rental payments hereinafter provided for, and the covenants hereinafter contained on the part of the lessee, the said lessors do hereby let, demise and lease unto the said lessee, its successors and assigns, the following described tract and parcel of real estate, towit: All tide and shore lands of the second class, formerly ownedd by the State of Washington, situate in front of, adjacent to or upon that portion of the government meander line lying in front of the following described uplands:

In front of lots one (1) and two (2), Section twelve (12) Township one (1) North Range Five (5) East of the Willamette Meridian, with a frontage of Fifty-three and Seventy-five hundreths (53.75) lineal chains. Also, beginning at the Point of intersection of the line between lots 2 and 3, section twelve (12) township one (1) north, range five (5) east of the Willamette Meridian with the government meander line, and running thence in front of a part of the said lot three (3) east 3.95 chains; South 33° East 3.80 chains; South 18° east 6.00 chains; South 45° West 2.00 chains; South 0.50 chains; South 74½° east 1.50 chains to the terminal point of this description, with a frontage of 17.75 lineal chains, the several descriptions together having a total frontage of 71.50 lineal chains, more or less, measured along the meander line, according to a certified copy of the government field notes of the survey thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington.

To have and to Hold the same unto said lessee, its successors and assigns for the term of Fifteen years from the 24th day of November 1908, the said lessee, its successors and assigns, paying therefor the annual rental of one dollar in gold coin for each year during said term. It is further agreed that the annual rental herein provided for shall become due on or before July 1st of each and every year, and if not paid within thirty days thereafter the said lessees their successors and assigns, shall forfeit all rights acquired by this lease.

It is further agreed that the said Washington and Northern Railroad at the expiration of this lease may renew this lease for a term of ten (10) years from the expiration of this lease, by paying Two Hundred and Fifty (250.00) dollars per year for said new lease. It is expecially agreed, however, that this lease is made only for the p purpose of enabling said Washington Northern Railroad, its successors and assigns to erect and maintain and operate a boom for logs and only for boom purposes and the said leasee hereby agrees to erect and maintain and operate said boom in a first class manner and way so as to interfere as little as possible with the use of said lands by the said Prindle. The said lessor further agrees to keep logs from off the beach or sands so as not so obstruct said Prindles wagon road. By accepting this lease, the said lessees shall and does agree and bind itself to make the rental payments about of

provided for at the time and in the manner above provided, and to keep and perform of the covenants made incumbent upon at by this indenture.
