

Baldwin To Asch

Know all Men In These Presents, that Frank Norman Baldwin, of Steunum Washington, a single man the party of the first part, for and in consideration of the sum of Two Hundred (\$200⁰⁰) Dollars to him in hand paid by N. K. Asch of Steunum, Washington the party of the second part, the receipt whereof is hereby acknowledged do by these presents grant, bargain, sell, convey and confirm unto the said party of the second part, his executors, administrators and assigns the following described personal property, located and being in Skamania County, State of Washington to-wit: all the standing and down timber, merchantable for logs, and the best half (1/2) of the Northwest quarter (NW 1/4) of Section Twenty-four (24) in Township Three (3) North of Range Seven (7) East of the Viccarville Meridian, except trees over four (4) feet in diameter or but said large trees to be designated by the parties hereto by blasing same. The timber hereby sold to be removed by the party of the second part within six months from the date hereof and the party of the first part hereby grants the necessary right of ingress and egress over and across said property for said period of six months for the purpose of removing said timber, including the right to construct and maintain suitable skid roads thereon during said term.

To Have and To Hold the same to the said party of the second part his executors, administrators and assigns forever And Frank Norman Baldwin does for his heirs, executors and administrators Covenant and agree to and with the said party of the second part his executors, administrators and assigns to warrant and defend the sale of such property, goods and chattels, hereby made unto the said

party of the second part his executor,
and assigns, against all and every
person and persons whomsoever, lawfully
claiming or to claim the same.
