

Marcum - to - Sears

Know All Men by these Presents: - That I, Roy A. Marcum of Stevenson, County of Skamania State of Washington, for and in consideration of the sum of one dollar, lawful money of the United States to me in hand paid by Carl Sears, of the same place, do hereby grant, bargain, sell, convey and deliver unto the said Carl Sears the following described personal property to-wit:

That certain Barber shop and Barber shop business situated in the Mc Kiegan Building, two doors South of the Postoffice, on the south side of Second Street in the town of Stevenson Skamania County, State of Washington, together with the fixtures, furniture, and attachments used in and about and in connection with such Barber shop and Barber business, and particularly three wash stands, one Back Mirror one front mirror, two lavatory wash stands, two Barber chairs (Token), 1 paper vase, 1 towel urn, 12 stand bottles, 1 settee, 1 box stove and pipe, 1 ideal water heater stove, 1 tank, 1 bath tub, 1 bath brush, 1 bath glass, 1 wide broom, 1 shine stand, 5 chairs, 2 cuspidors, 300 face towels, 42 bath towels, 36 steam towels, 7 tons coal, all plumbing and drains now attached to the wall and drains from where the same come through the basement wall, all barber supplies, hooks screwed on wall for hats, 2 shade and globe light, 1 globe in bath room, 1 electric Barber pole, 5 window shades, one door shade,

To Have and To Hold unto the said vendee his heirs, executors, administrators and assigns forever,

The said Vendor does hereby covenant and agree to and with the vendee, his heirs, executors, administrators and assigns, that he is the true and lawful owner of said personal property, has good right to sell the same, and that the same is free and clear of all incumbrances.

The vendor further agrees with the vendee that he will not enter into an opposition Barber business within said town of Stevenson within a period of two years from and after the date of this Bill of Sale.
