Skamania County of Cape Horn R.R. Co.

Franchise .

In the matter of the petition of the Cape Horn Railway Company for a franchise
to construct, maintain and operate a railway on, over and across certain roads in
Skamania County, Wash.

Now on this sixth day of August 1908 this matter comes before the Board of
County Commissioners of Skamania County, Washington, for hearing pursuant to
the notice heretofore given, and it appearing to the board that due and legal
notice of said hearing was given in the manner and for the length of time required
by law, and that no objection to the granting of the said franchise has been made or
filed or entered herein, and the petitioner above appearing by its agent J.W. Coovert
and all things being in readiness the hearing was proceeded with, and the Com-
missioners being fully advised in the matter and understanding all and singular
the law and the facts in relation to the same do determine that the said petition
for the said franchise be granted.

And it is ordered and adjudged and this does order and adjudge that the
Cape Horn Railway Company, a Washington Corporation, be and it is hereby granted
a franchise to use the roads hereinafter described in Skamania County, Washington,
for the purpose of construction, maintaining and operating on, over and across
the same in the manner and subject to the conditions hereinafter set forth a rail-
way, and to convey thereover cars and trains of whatsoever description it shall
use in the course of its business, propelled by steam power. The said roads being

described as follows, to wit: The Cascade Road on the Prindle farm, the Henry Gunther Road, and the Branch of the Logging camp Road leading to M. Tavelli's ranch.

And it is ordered and adjudged that the said railroad shall be built at the places and in the manner as follows, viz; 1st. On, over and across the Cascade road at a point located as station 16+70 of the said railroad according to the survey thereof, the same being situated on the Prindle farm about fifty feet north of the south line of Section one (1) Township one (1) North of range five (5) east of W.M. The crossing at said place being a grade crossing at an angle of 44 deg.

2nd. On, over and across the Henry Gunther road at a place located as station 95 of said railroad, the same being on the Caroline Fischer ranch between three hundred and six hundred feet east of the west line of section two (2) in Township one (1) North of range five (5) east of W.M. The crossing at said point being an overhead crossing fifty four feet high and at an angle to said road of 88 deg.

3rd. On, over and across the branch of The Logging road leading to M. Tavelli's ranch at a place located as station 133+50 of said railroad, the same being four hundred forty feet south and one hundred forty four feet east of the quarter section corner of the north line of section two.

And it is ordered and adjudged that the said Corporation shall and may have and use the said roads as aforesaid for the purpose above specified, provided, the said railroad be constructed, maintained and operated in manner as will cause the least interference with the other use of the said roads. And provided that said railroad crossing be constructed, maintained, and operated in such manner as shall be approved by the County Engineer of Skamania County.

And it is ordered and adjudged and this does order and adjudge that the said franchise be and the same is hereby granted for the term of 15 years from date hereof.
