THIS INDENTURE made this 25th day of June 1908, by and between Geo.S. Shepherd and John A. McQuinn of the County of Skamaria, State of Washington, and J.E. Blazier of Multnomah County, State of Oregon, Witnesseth:

That in consideration of the covenants hereinafter contained, on the part of the said J.E. Blazier, to be kept and performed by him, the said Geo.S. Shepherd and John A. McQuinn do hereby lease, demise and let unto the said J.E. Blazier his heirs, executors, administrators and assigns the following described tract and piece of real estate, to-wit: a strip of land being sufficiently wide to construct and operate a single track standard gauge Logging Railroad across our farm in Skamania County, State of Washington, the same being the NW% of NE2 of Sec.35 Town 2 North Range 5 East said strip of land to be used as a right of way upon which to construct and operate a logging railroad, and the same to be safficiently wide to construct and operate a single track standard gauge Logging Railroad as the same is now, located and constructed over, through and upon the said farm aforesaid.
