VINCENT TO COUNTS.

THIS AGREMENT, made in duplicate and entered into this 19th day of August, 1916, by and between Etta Ramsey Vincent of Portland, Muhtmomah County, Oregon, hereinafter called first party, and Susan T. Counts, of Sherwood, Washington County, Oregon, hereinafter called second party,

WITNESSETH, That first party in consideration of the covenants and agreements on the part of second party, hereinafter contained, agrees to sell and convey unto second party and second party agrees to buy all that certain tract of real property situate in the County of Skamania , State of Washington, described as follows, to wit: Commencing at the quarter corner of sections 21 and 28 Township 3 North of Range 10 East of the Willamette Meridian thence south 89 deg. 03 18" East 1146.54 feet to the Gov. Meander Corner; thence North 0 deg. 21. West 957.1 feet; thence south 89 deg. 56 West 1167.80 feet; thence south 0 deg. 03 West 980.45 feet to the place of beginning containing 22 acres, more or less, and being in said Sec. 21 T. 3 N. of . Range 10 East of the Will: mette Meridian for the sum of Twelve Hundred (\$1200.00) Dollars, to be paid in the manner following, to-wit: \$76.00 on the execution of this contract, the receipt whereof is hereby acknowledged by first party and the balance as follows, to-wit: \$224.00 to be paid in installments of not less tham \$20.00 perimonth and the full sum of \$224.00 is to be paid on or before the lat day of April, 1917, without interest. That on the said 1st day of . wril, 1917, or at such time as said second party shall have paid first party a total sum of \$300.00 then and in & that event first party shall and will make, execute and deliver unto second party a good and sufficient warranty deed to the above described premises, and furnish an abstract of title brought down to date showing said property free free and clear of all incumbrances whatsoever up to and until the date of said deed, and that at said time said first party makes, executes and delivers said warranty deed to second

party, second party covenants and agrees to make executed and deliver unto first here certain note in the sum \$900.00 secured by a mortgage on the above described real property and first party agrees to accept said note and mortgage in payment of the balance of the purchase price of said real property. Said note shall be made for a periodnof 5 years from said 1st day of April. 1917, and shall draw interest at the rate of 6% per annum payable semi-annually.
