## ALBERT WHITEHEAD TO ALFRED J. SHEPLER

FOR THE CL SIDERATION AND RENT HEREINAFTER PROVIDED FOR AND RESERVED, AND SUBJECT TO THE RESTRICTIONS AND RESERVATIONS HEREINAFTER MENTIONED, ALBERT WHITEHEAD, AS LESSON OWNER OF THE USE OF THE WATERS OF THE SPRING HEREINAFTER MENTIONED, DOES LEASE, REMISE AND LET UNTO ALTRED J. SHEPLER, AS LESSED, ALL OF THE WATER FLOWING FROM THAT CERTAIN SPRING LOCATED NEAR THE NORTH SIDE OF THE SOUTHEAST QUARTER (SEC) OF THE NORTHWEST QUARTER (NWW) OF FIGT ON SEVEN (7), TOWNSHIP THREE (3), NORTH, RANGE TEN (0), E. W.M., TOGETHER WITH THE RIGHT OF SAID LESSEE TO APPROPRIATE AND DIVERT SAID WATERS FROM SAID SPRING AND CONVEY THE SAME SOUTHWARD AND INTO SECTION EIGHTEEN (13) WATER THE SAME SHALL BE USE FOR DOMESTIC USE AND FOR POWER PURPOSES FOR A SAWMILL.

TO HAVE AND TO HOLD THE USE OF SUCH WATER FOR SUCH PURPOSES FOR THE TERM OF FIVE (5) YEARS FROM AND AFTER JUNE 1, 1916.

AS RENT FOR THE USE OF SUCH WATER 1.3SEE DOES AGREE TO PAY TO LESSOR THE SUM OF ONE (\$1.30) DOLLAR PER YEAR FOR EACH OF THE YEARS OF THE TERM HEREIN FIXED, PAYABLE IN ADVANCE.

SAID WATER SHALL BE USED BY THE LESSEE FOR THE PUPPOSES ABOVE MENTIONED, AND FOR NONE OTHER. AND IF AT ANY TIME DURING THE TERM OF THIS LEASE, LESSOR SHOULD REQUIRE WATER FOR IRRIGATING HIS LAND IN SECTION TWELVE (12), TOWNSHIP THREE, NORTH, RANGE NINE (9), E. W.M., AND SECTIONS SIX AND SEVEN (6 AND 7), TOWN-SHIP THREE (3), NORTH, RANGE TEN (10), E.W.M., OR ANY PART THEREOF, THEN AND IN THAT CASE, UPON NOTICE TO THE LESSEE OF SUCH REQUIREMENT, SAID LESSEE WILL CAUSE THE WATERS OF TWO CER AIN SPRINGS LUCATED UPON THE SOUTHWEST QUARTER (SWE) OF THE Southwest quarter (SW2) of Section Six (6), Township Three (3), North, Range Ten ((0), E. W.M., AND TO WHICH LESSOR IS ENTITLED TO THE USE, TO BE FLUMED DOWN TO AND UPON SUCHAOF LESSOR'S LANDS AS ARE SO DESIRED AND REQUIRED TO BE IRRIGATED, ALL AT HIS, THE LESSEE'S SOLE COST AND EXPENSE; OR, LESSEE, AT HIS OPTION, WILL FURNISH TO LESSOR IN GASH THE COST OF SO FLUMING AND CONVEYING SUCH WATER. AND IN CASS OF LESSEE'S REFUSAL OR NEGLECT TO FU DC AS HE IS LAST HEREINABOVE REQUIRED TO DO, LESSOR MAY THEREUPON AND IMMEDIATELY, WITHOUT FURTHER NOTICE, DECLARE THIS CONTRACT CANCELLED AND OF NO FURTHER EFFECT AND MAY RE-POSSESS HIMSELF OF THE WATERS HEREIN SO LEASED TO THE LESSEE.

AT THE EXPIRATION OF THE TERM OF THIS LESSEE WILL REMOVE ALL PIPE, MACHINERY OR OTHER STRUCTORS OR APPARATUS AWAY FROM IN AND ABOUT THE SAID SPRING, THE WATERS OF WHICH ARE HEREIN LEASED, 50 AS TO GIVE TO LESSOR THE SAME ACCESS TO THE SAME FOR THE PURPOSE OF DIVERTING WATER THEREFROM THAT HE NOW ENJOYES.

AND AS A FURTHER CONSIDERATION FOR THIS LEASE, LESSEE DOES GRANT, BARGAIN, SELL AND CONVEY UNTO LESSOR THE RIGHT, PRIVILEGE AND EASEMENT FOR THE NECESSARY RIGHT OF WAY IN, THROUGH, UPON AND ACROSS THE SOUTHEAST QUARTER (SEX) OF THE NORTH-WEST QUARTER (NW.)
