KNOW ALL MEN BY THESE PRESENTS: THAT I, OTTO PETERS, OF PORTLAND, OREGON, THE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN AND NO/100 DOLLARS, GOLD COIN OF THE UNITED STATES OF AMERICA, TO ME IN HAND PAID BY GUS V. BARKS, PARTY OF THE SECOND PART, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARPAINED, SOLD, ASSIGNED, TRANSFERRED, AND SET OVER AND DO BY THESE PRESENCE GRANT, BARGAIN, SELL, TRANSFER AND SET OVER UNTO GUS V. BARKS, THE PARTY OF THE SECOND PART HEREIN ALL MY RIGHT, TITLE AND INTEREST IN AND TO A CERTAIN INDENTURE OF CONTRACT TO PURCHASE LOTS THREE AND FOUR AND THE SOUTHEAST ONE-FOURTH OF THE SOUTHWEST ONE-FOURTH, AND THE SOUTH ONE-HALF OF THE NORTHEAST ONE-FOURTH OF THE SOUTHWEST ONE-FOURTH SECTION 31 TOWNSHIP 2 RANGE 5 EAST OF THE WILLAMETTE MERIDIAN IN SKAMANIA COUNTY, WASHINGTON, SAID CONTRACT BEING EXECUTED BY MINA B. WALLACE, C. G. HUNTLEY LENA A. HUNTLEY, W. A. G. WALLACE, GUS V. BARKS AND OTTO PETERS, AND DATED THE 31ST DAY OF OCTOBER A.D. 1916, BEING RECORDED IN BOOK 2 OF CONTRACTS, PAGE 401 OF THE COUNTY RECORDS FOR SKAMANIA COUNTY, WASHINGTON.

I FURTHER ASSIGN SET OVER AND TRANSFER UNTO THE SAID GUS V. BARKS, ALL MY RIGHT, TITLE AND INTEREST THAT I MAY HAVE IN AND TO ANY WOOD CONTRACT OR CONTRACTS, EXISTING BETWEEN MYSELF, THE SAID GUS V. BARKS AND OTHER PARTIES. I FURTHER ASSIGN, SEL', SET OVER AND TRANSFER UNTO THE SAID GUS V. BARKS ALL MY INTEREST, RIGHT AND TITLE TO ANY EQUIPMENT, SUCH AS HORSES, WAGONS AND WOOD CUTTING MACHINERY USED BY US IN THE OPERATION OF OUR WOOD CAMP LOCATED AT OR NEAR PRINDLE, WASHINGTON, UPON A PORTION OF THE ABOVE DESCRIBED PROPERTY.
