INGTON DO HEREBY RELEASE CHAUNCE GOODENOUGH FROM ALL OBLIGATIONS FROM THAT CERTAIN
LEASE MADE AND EXECUTED ON THE 17TH DAY OF NOVEMBER 1919 AND RECORDED DECEMBER 3RD
1919 IN BOOK TWO OF LEASES ON PAGE #23 RECORDS OF SKAMANIA COUNTY STATE OF WASH-
INGTON.

THE INTENTION OF THE SAID OTTO J. JAHNSEN BEING TO RELEASE THE SAID CHAUNCE
GOODENOUGH FROM ALL OBLIGATIONS UNDER THE TERMS OF THE SAID LEASE THE SAME AS IF IT
HAD NEVER BEEN MADE.

HOWEVER,
THE SAID OTTO J. JAHNSEN RESERVES FOR HIMSELF FROM THIS RELEASE, THE THE
RIGHT OF A REASONABLE LENGTH OF TIME TO VACATE THE SAID PREMISES AND DISPOSE OF HIS
CROPS, UNDER THESE TERMS THE THE TIME BETWEEN THIS DATE AND THE FIRST DAY OF MARCH
1921 SHALL BE CONSIDERED TO BE A REASONABLE LENGTH OF TIME.
