THIS AGREEMENT, MADE AND ENTERED INTO THIS 20TH DAY OF MARCH, 1918, BY AND BETWEEN J. F. RIDENOUR AND ADA S. RIDENOUR, HUSBAND AND WIFE, OF YAMHILL COUNTY, OREGON, HEREINAFTER CALLED THE PARTIES OF THE FIRST PART, AND WILLIAM H. PUTNAM, RECEIVER FOR THE J. K. LUMBER COMPANY, BY APPOINTMENT OF THE UNITED STATES DISTRICT COURT FOR THE SOUTHERN DIVISION OF THE WESTERN DISTRICT OF WASHINGTON, HEREINAFTER CALLED THE PARTY OF THE SECOND PART;

WITNESSETH:

IT IS MUTUALLY AGREED BETWEEN THE PARTIES HERETO THAT THE LOGGING RAILROAD, DUMP AND UNLOADING FACILITIES FOR LOGS, BELONGING TO THE PARTIES OF THE FIRST PART, SITUATED ON SNOOK'S DONATION LAND CLAIM, IN SECTION TWENTY-FIVE (25), TOWNSHIP TWO (2) NORTH, RANGE SIX (6) EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, MENTIONED AND DESCRIBED IN THAT CERTAIN LEASE ENTERED INTO BETWEEN THE PARTIES HERETO ON THE 11TH DAY OF DECEMBER, 1917, DID ON THE DATE OF THE EXECUTION OF SAID LEASE, CONSIST OF THE FOLLOWING, TO-WIT:

ONE MAIN LINE LOGGING RAILROAD, CONSISTING OF TWO HUNDRED FORTY-EIGHT (248) FIFTY-SIX POUND, STANDARD STEEL RAILS, EACH APPROXIMATELY THIRTY FEET IN LENGTH, TOGETHER WITH TIES FOR SAME; ONE SIDING ADJACENT TO SAID MAIN LINE LOGGING RAILROAD, CONSISTING OF THIRTY-FOUR (34) FIFTY-SIX POUND, STANDARD STEEL RAILS, EACH APPROXIMATELY THIRTY FEET IN LENGTH, WITH TIES THEREFOR, AND ONE FROG SITUATED AT THE JUNC -

TION OF SAID SIDING WITH SAID MAIN LINE RAILROAD, ALL AS CONSTRUCTED, PLACED AND BUILT ON SAID DONATION LAND CLAIM ON THE DATE OF THE EXECUTION OF SAID LEASE, AND THAT ALL OF THE PROPERTY HEREIN DESCRIBED SHALL BE SURRENDERED AND DELIVERED OVER TO THE PARTIES OF THE FIRST PART UPON THE EXPIRATION OF THE TERM OR SOONER TERMINATION OF SAID LEASE, IN AS GOOD ORDER AND CONDITION, (REASONABLE USE AND WEAR THEREOF, FIRE AND OTHER UNAVOIDABLE CASUALTIES EXCEPTED), AS THE SAME WERE IN ON THE DATE OF EXECUTION OF SAID LEASE.
