The Seller retains title to the goods and a security interest therein and in all replacements and additions thereto, under the Uniform Commercial Code, to secure payment and performance of all obligations of the Buyer hereunder.

"ADDITIONAL PROVISIONS" AND "STATEMENT CONCERNING WARRANTIES" ON THE REVERSE SIDE ARE INCORPORATED HEREIN BY REFERENCE.

NOTICE TO BUYER: 1. Do not sign this contract before you read it or if it contains any blank spaces. 2. You are entitled to an exact copy of the contract you sign. 3. Under the law, you have the following rights, among others: (a) to pay off in advance the full amount due and, under certain circumstances, to obtain a partial refund of the finance charge based on the Rule of 78; (b) to redeem the property if repossessed for a default within the time permitted by law; (c) to require, under certain conditions, a resale of the property if repossessed.
