Wind River Logging Company, Claimant vs. Quality Vencer and Lumber, Inc.

Notice is hereby given that Wind River Logging Company of Skam mia County, State of Washington, claims a lien upon logs of 170,950 board feet of Douglas-fir and 39,110 board feet of white fir and hemlock, which were cut in Skamania County, State of Washington, identified with brand 86, a heart-shaped symbol, on most of the logs. The logs are now lying in Decks 3, 6, 6A, 13A, 15C, 217, 27, and ML at the Hanel Lumber Log yard, Hood River County, Oregon and were delivered to the mill in the loads identified in Exhibit A. The Hanel Lumber Log yard is owned by Quality Veneer and Lumber, Inc., which has its principal place of business in Seattle, King County, Washington. The name of the owner is Wind River Logging Co., who felled, bucked, yarded, loaded, and trucked the 12gs, and contracted with Quality Veneer and Lumber, Inc., Hanel Lumber Division, to process the logs upon the following terms and conditions, to wit:

Quality Veneer and Lumber, Inc., agreed to pay Wind River Logging Co. for such work performed; that the contract has been faithfully performed and fully complied with by Wind River Logging Co.; that the work was performed on logs that were delivered between June 27, 2000 and July 25, 2000, and sixty days have not elapsed since that time; that the amount of claimant's demand for the labor performed is \$30,771.00 for the work performed on Douglas-fir and \$7,039.00 for the work performed on white fir and hemlock, totaling \$37,810.00; that no amount has been paid; and there is now due and remaining unpaid, after deducting all just credits and offsets,
