- SECTION 3 This area must be signed by all registered owners of the manufactured home when processing a title elin-ination. If the manufactured home has been sold and is being removed from the seal property, the owners por the real property records must compliste this portion to obtain a Certificate of Title. Signatures of the owners must be notatized or certified by the selling dealer or a vehicle licensing agent. Fees will include a tiling and applic that fee plus sales or use tax due. Additional fees may include: a title elimination fee and a Mobile Home Affairs Fee. Subagents will charge an additional service fee. (Faes are subject to change without notice.)
- SECTION 4 Take the properly completed Manufactured Home Application and all necessary supporting documents to the County Auditor/Licensing Agent Office for approval. Supporting documents may include but are not limited to: proof of owner thip or a Manufacturer's Statement of Origin (MSO), proof of taxes paid, and applicable release(s) of interest. Subagents may not complete an approval portion of this form.
- SECTION 5 The "Title Company Certification" box must be completed when processing a Transfer in Location" or a "Removal From Real Property" application. Important: The line recorded application form must be submitted to a vehicle licensing agent within 10 days of the title company's certification.
