





A Tract of land in the Southeast Quarter of Section 25, Township 3 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Lot 2 of the Davison Short Plat recorded in Book 3 of Short Plats, Page 300, Skamania County Records.

Together with an easement for Access over Lot 1 of the Short Plat recorded in Book 3 of Short Plats, Page 300 as follows:

Easement shall consist of all the Land between points on the South and Western boundary on Lot 1. These points measure from the Southwest corner of Lot 1, 17 Feet North to 41 Feet North along the Western Boundary line of Lot 1 and 15 Feet East to 34 Feet East along the Southern Boundary line of Lot 1. This easement is named Jamcatts Rd. and shall only be used to access Lot #2. As recorded in Book 200, Page 404.
