## Exhibit A

A Tract of land in the Southeas: Quarter of Section 25, Township 3 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Lot 2 of the Davison Short Plat recorded in Book 3 of Short Plats, Page 300, Skamania County Records.

Together with an easement for Access over Lot 1 of the Short Flat recorded in Book 3 of Short Plats, Page 300 as follows:

Easement shall consist of all the Land between points on the South and Western boundary on Lot 1. These points measure from the Southwest corner of Lot 1, 17 Feet.
