DURABLE POWER OF ATTORNEY

EDWARD A. JACKSON, residing at White Salmon, Klickitat County, Washington, as authorized by RCW 11.94, hereby names his son, CARL E. JACKSON, currently of White Salmon, Washington, as attorney-in-fact with the intention that this designation of durable power of attorney shall remain in force and not be limited by any future disability or incompetence of the principal. In the event CARL E. JACKSON shall be unwilling or unable to act as attorney-infact, EDWARD A. JACKSON appoints his daughter-in-law, SARAH DIANE JACKSON, currently of White Salmon, Washington, as alternate attorney-in-fact, with all the same powers as granted unto the first-named attorney-in-fact.

- 1. POWERS.
- (a) General Powers. The attorney-in-fact shall act as a fiduciary for the principal. The attorney-in-fact shall have all powers over the principal's estate that the principal has or acquires, both within and without the State of Washington, except for those powers specifically excluded in paragraph l(c) of this document. In the event of the principal's disability or incompetence the attorney-in-fact shall have equal powers over the principal's person as well.
- (b) <u>Specific Powers.</u> The atterney-in-fact shall have all powers as are necessary or desirable to provide for the support, maintenance, health, emergencies, and urgent necessities of the principal. The specific powers of the attorney-in fact shall include, but not be limited to, the following:
 - (1) To have the sole and exclusive authority to determine medical treatment for the principal, if the principal shall be physically or mentally incapacitated or otherwise unable to make such authorization for himself, including authorization for

emergency are, hospitalization, surgery, therapy and/or any other kind of treatment which the attorney-in-fact shall, in his or her sole discretion, think necessary.

- (2) To be given first priority, along with the other members of the principal's family, in visitation should the principal be a patient in any institution and unable to express a preference on account of his illness or disability.
- (3) To make pre-arrangements for the principal's funeral and method of disposition and execute any funeral arrangement and method of distribution contracts on the principal's behalf.
- (4) To buy, receive, lease, borrow, accept, or otherwise acquire; to sell, convey, lend, release, waive, mortgage, quit claim, or otherwise encumber or dispose of; to revoke, create, or modify any trust of; or to contract or agree for the acquisition, disposal, or encumbrance of, any property whatsoever or any custody, possession, interest, or right therein, upon such terms as the said attorney-in-fact shall think proper.
- (5) To make, endorse, accept, receive, sign, seal, execute, acknowledge and deliver deeds, mortgages, leases, assignments, agreements, certificates, obligations, checks, notes, bonds, vouchers, receipts, notices, claims, proofs, proxies, stock powers, bond or stock certificates and such other written instruments of whatever kind and nature as may be necessary, convenient, or proper in the premises.
- (6) To deposit, withdraw or transfer any money or credits in any banking or building, savings, loan or credit union institution or any other depository, or investment or execute and renew any checks, withdrawals, deposits, promissory notes, bonds, bills or exchange or evidences of indebtedness and to waive notice of demand and other protest and to transact and perform any and all other banking or financial business and affairs of any kind whatsoever, including accessing any safe deposit box, as fully and completely as the principal may do if present.
- (7) To pay, settle, compromise or otherwise discharge any and all claims of liability or indebtedness against the principal, and, in so doing, use any of the principal's funds or other assets or use

funds or other assets of the attorney-in-fact and obtain reimbursement out of the principal's funds or other assets.

- (8) To participate in any legal action in the name of the principal or otherwise. This shall include (a) actions for attachment, execution, eviction, foreclosure, ademnity, and any other proceeding for equitable or injunctive relief and (b) legal proceedings in connection with the authority granted in this instrument.
- (9) To in all ways manage the rental, maintenance and conveyance of, my house and real property in Kalama, Washington, located at 364 Juniper Street, Kalama, Washington.
- (c) <u>Exclusions.</u> The attorney-in-fact shall not have the power to revoke or change any estate planning or testamentary documents previously executed by the principal except as provided herein.
- 2. <u>EFFECTIVE DATE.</u> This power of attorney shall become effective immediately.
- 3. <u>DURATION</u>. This Durable Power of Attorney becomes effective as provided in paragraph 2, and shall remain in effect until revoked or terminated under the terms of paragraph 4.

4. REVOCATION AND TERMINATION.

- (a) Revocation. This power of attorney may be revoked, suspended or terminated in writing by the principal with written notice to the designated attorney-in-fact and by recording the written instrument of revocation in the office of the recorder or auditor of the principal's residence to wit the auditor's office of Klickitat County in Goldendale, Washington.
- (b) <u>Termination by Death of the Principal</u>. The death of the principal shall be deemed to revoke this power of attorney upon actual knowledge or actual notice being received by the attorney-in-fact.

- (c) Nomination of Guardian. If guardianship or protective proceedings are commenced in the appropriate court for the appointment of a guardian or limited guardian of the principal's estate or person, the principal hereby nominates the attorney-in-fact as the appropriate person to appointed as guardian or limited guardian if the guardianship is deemed necessary by the court. Pursuant to RCW 11.94.010, the court shall appoint the attorney-in-fact as the principal's guardian or limited guardian if this nomination is the principal's most recent nomination made in a Durable Power of Attorney. The court shall not appoint the attorney-in-fact as the principal's guardian or limited guardian only if good cause is shown or if the attorney-in-fact is deemed disqualified.
- (d) <u>Termination by Appointment of Guardian</u>. This power of attorney may be terminated, revoked, or suspended by any person who is appointed by the Superior Court to be guardian of the estate of the principal; however, court appointment of a guardian of the person of the principal shall not affect this power of attorney.
 - 5. RIGHTS AND DUTIES OF THE ATTORNEY-IN-FACT.
- (a) Reliance. The attorney-in-fact and all persons dealing with the attorney-in-fact shall be entitled to rely upon this power of attorney so long as it is effective, and has not been revoked, suspended, or terminated. Any action taken in reliance on this document unless otherwise invalid or unenforceable shall be binding on the heirs, devisees, legatees, or personal representatives of the principal.
- (b) <u>Indemnity</u>. The estate of the principal shall hold harmless and indemnify the attorney-in-fact from all liability for acts done in good faith and not done in fraud of the principal.

- (c) <u>Accounting</u>. The attorney-in-fact shall be required to account to any subsequently appointed personal representative.
- (d) <u>Compensation</u>. My attorney-in-fact shall receive reasonable compensation for services rendered.
