THIS MATTER having come on for hearing in open court before the undersigned Judge/Court Commissioner of the above-entitled court, the Plaintiff appearing through its attorney, William P. McArdel III, and an Order of Default having previously been entered against the above-named Defendant, and the Court having considered the Declaration of William P. McArdel III regarding the amount due, NOW, THEREFORE, in accordance therewith,

IT IS ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

1. That the Plaintiff have and receive Judgment against the above-named Defendant, STEVEN D. HICKEY, in the principal judgment amount of \$4,841.13, plus pre-judgment interest of \$147.40, together with costs of \$204.00 herein incurred, and an attorney's fee of \$275.00, for a total of \$5,467.53. The principal Judgment shall accrue interest at the rate of 22.68% per annum until paid, and the Judgment for attorney's fees and costs of \$479.00 shall accrue interest at 12% per annum until paid.

2.
