Dear Mr. Shockey:

On Friday, January 22, 1999, an illegal methamphetamine drug lab was confiscated by the Washington State Patrol Drug Lab Team while executing a search warrant at the address referenced above.

The Southwest Washington Health District designated the residence (mobile home) unfit for use on February 18, 1999, and recorded such document, dated March 10, 1999, with the Skamania County Auditor on March 10, 1999, Recording No. 134528, Book 187, pages 297-307,

I have received and reviewed the PHASE 1 ENVIRONMENTAL SITE ASSESSMENT, 22.7-ACRE PROPERTY, 62 EASTWOOD LANE, WASHOUGAL, WASHINGTON report and Septic Tank Sampling Letter Report, both prepared by Maul Foster & Alongi, Inc., Vancouver, WA, Project 0016.01.01, dated February 14, 2002, and the pictures of the septic tank abandonment, and receipt and statement of work for demolition debris hauling and disposal of the mobile home.

To the best of my knowledge, the basis upon which the property was originally declared unfit for use has been addressed by demolition in accordance with procedures deemed appropriate by the Southwest Washington Health District Health Officer. In addition, your reported well abandonment by filling with concrete is appropriate as per my discussion with Bruce Scherling, EHS of the Health District Stevenson office.

The above documentation verifies reduction of contamination to acceptable levels for reuse as stated in the Washington State Department of Health, Office of Toxic Substances, Guidelines for Contamination Reduction and Sampling at Illegal Drug Manufacturing Sites.

As the legal owner, you are responsible for notifying all future inhabitants, purchasers or real estate agents that the property was used as an illegal drug lab. A fact sheet about illegal methamphetamine labs is included with this letter.

ILLEGAL METHAMPHETAMINE LABS

Revised April 1995 Fact Sheet

ethamphetamine, also known as "crank" or "speed", is a potent central nervous system stimulant with the potential to cause drug dependence. Possession, manufacture, or distribution is unlawful in many countries, including the United States.

WHAT IS AN ILLEGAL LAB?

An illegal mechamphetamine or crank lab is one which is set up to produce this illegal drug. There are several different technique; used to produce methamphetamine. All of the processes use a variety of chemicals including explosives, solvents, meals, salts, and corrosives. During the drug manufacturing process (cooling), additional compounds and byproducts are produced. The fumes, vapors, and spillage associated with cooling can be toxic.

Possible Health Effects

The risk of injury from chemical exposure depends on the chemical itself, the concentration, the quantity, and the length and route of exposure. Chemicals may enter the body by being breathed, eaten, injected (by a contaminated needle or accioental skin prick), or absorbed by the skin

Acute Emposures: An acute chemical exposure is one that occurs over a relatively short period of time and may result in health effects.

An acute exposure to high levels of contaminants found in methamphetamine labs cause shortness of breath, cough, chest pain, dizziness, lack of coordination, chemical irritation, and burns to the skin, eyes, mouth and nose, and in severe cases, death. Acute reactions of this nature could occur during or immediately after a drug but, before the lab has been ventilated.

Less severe symptoms resulting from a less acute exposure cause he dache, nausea, dizziness, and fatigue or lethargy. These symptoms have been known to occur in people who have entered a drug lab after the bust has been completed, but before the property has been adequately cleaned and

ventilated. These symptoms usually go away after several hours.

Corresive Effects: Inhalation or skin exposure may result in injury from corrosive substances present in a methamphetamine lab. Symptoms range from shortness of breath, cough, chest pain, to burns to the skin.

Solvents: Exposure to solvents can irritate the skin, mucous membranes, respiratory tract, and cause central nervous system effects. The are also dangerous because of their fire and explosive properties.

Chronic Exposure: Chronic exposure occurs over an extended period of time, such as weeks, months, or years. A chronic health effect is one that usually appears after a lengthy period of time, possibly years. Not much is known about the chronic health effects from these labs. However, there is scientific evidence from animal and human toxicity studies that shows the chemicals used in the manufacture of this drug can cause a range of health effects. These include cancer, damage to the brain, liver and kidneys, birth defects, and reproductive problems, such as miscarriages.

RECOMMENDATIONS

In summary, because of the possible health effects associated with methamphetamine labs:

 No one should enter a place that has been used as an illegal methamphetamine drug lab without appropriate personal protective equipment unless the area has been ventilated and decontaminated.

- No one should rent, purchase, or otherwise occupy a house or dwelling which has been used as an illegal drug lab until the property has been decontaminated according to the best available technology. Washington State law requires notice on property title.
- The decision to rent, purchase or otherwise occupy a house or dwelling which has been used as a drug lab should be made with the knowledge that no decontamination procedure can guarantee absolute safety for reoccupancy0
