EXHIBIT "A"

A tract of land located in the North half of the Northwest Quarter of the Southwest Quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at a point 1,980 feet East of the quarter corner of the West line of said Section 17; thence South 660 feet to the South line of the North half of the Northeast Quarter of the Southwest Quarter of the said Section 17; thence East along said South line 660 feet, more or less, to the quarter section line; thence North 660 feet to the center of said Section 17; thence West 660 feet, more or less, to the point of beginning.

ALSO known as Lots 1 and 2 of TED AND LOIS SAMS PLAT OF ALEGRIA PARK, a Mobile Home Park, recorded in Book B of Plats, Page 22, Auditor's File No. 84181.

EXCEPT a parcel of land in a wedge shape being a part of and lying on the North side of the Southwest Quarter of Section 17, Township 3 North, Range 8 East of the Willamette Meridian and lying North of the center of the present County road.
