## EXHIBIT "A"

A tract of land located in the Baughman D.L.C., Section 2, Township 2 North, Range 7 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at an iron pipe marking the intersection of the East line of the said Section 2 with the division like between the Northeasterly and Southwesterly halves of the said Baughman D.L.C.; 301.32 feet to the initial point of the tract hereby described; 216.46 feet to intersection with the said division line; thence south 47° 21' West South 64° 10' East along the said division line; thence initial point.
