I. BASIS


1. Per the Respondent filing a temporary security order or restraining order, the Petitioner hereby creates a voluntary security pledge with penalties per violation.
2. The Respondent stated on 10-29-01 at her apartment in front of Julie that it was desirable to remove me from all ministries and does not care of the irreparable harm caused, to wit:
 - A. They cause the Petitioner to be falsely labeled by a court "Harmful" thus he cannot continue in the office of Chaplain for the VFW.
 - B. Same reason, Petitioner cannot do voluntary work and counseling for the American Red Cross.
 - C. Same reason, Petitioner cannot work with the Boy Scouts at Calvary Chapel in Vancouver.
 - D. Same reason, the Petitioner cannot work with Pastor Rob at the Yale Community Church in Cougar.
 - E. Same reason, the Petitioner's Bank loan could be canceled for his business.

For same reason, the Petitioner would be required to list this action on all job applications, reducing the ability to be employed.

3. Therefore, the Petitioner now creates a voluntary and irrevocable security pledge to the Respondent, with enforcement and penalty actions given below.

- A. The Petitioner will voluntarily avoid any and all contact with the Respondent by all means staying away 10 miles of her known presence and will not initiate any form of communication by mail or phone, unless to respond to a question.
- B. The Petitioner, on a chance meeting, will immediately leave the area and not engage in any conversation or have any contact whatsoever.
- C. The Petitioner, in good faith, deposits 3 gold coins worth approx. \$300 each with daughter & Personal Representative, Laurie Hunger-Stevens in trust to be arbitrated & paid to Respondent upon written violation of this agreement, and written response from Petitioner. The P. A. will read both sides and decide and all decisions are final and binding.
- D. The Petitioner promises to keep the trust account above \$500 at all times and if needed, the Personal Representative has knowledge and control over other gold assets to replace the trust fund, as needed.
- E. Upon the death of the Petitioner, all remaining funds will be given to any grandchildren, in equal cash or metal amounts for their college fund.
- F. Joint meetings with family or counseling sessions will be allowed, but contact will be limited and avoided before and after these events or sessions.
- G. The Respondent is also restricted from the cabin residence of the Petitioner, except for a national emergency or with another family member at their invitation who have free access to the cabin at any time. A written notification as to time of arrival & departure is desirable, to avoid any conflicts with weddings or other cabin activities, with denials by phone.
- H. The Respondent and Petitioner need this safe haven security system to put aside any worries of the other and focus on other matters.
- I. The Respondent must be sensitive to other concerned residents living at Northwoods and limit the visit to the cabin for a community cooling down period of six months or May 1, 2002, in order to promote peace and harmony!
- J. This agreement can be only broken in writing by the Respondent.
