A tract of land in the Felix G. Iman Donation Land Claim in Section 2, T. 2 N., R. 7 E.W.M., Skamania County, Washington, described as follows: Beginning at the northwest corner of the D. Baughman Donation Land Claim, said point being in the right-of-way for the county road known and designated as the Red Bluff Road; thence south a distance of 132 feet to the true point of beginning; thence west 190 feet; thence north 132

PROVISIONS

All conditions and requirements contained in reports of examination or permits previously issued apply to this certificate unless specifically noted below.

"Groundwater certificate G2-28119 has been issued to allow a withdrawal of 100 gpm and 80 acre-feet per year from a well (Skamania Lodge Well #1), for discharge into Iman Lake. The water withdrawn from Well #1 and added to Iman Lake will be available for withdrawal from the lake for irrigation purposes. Therefore, the impacts of this surface water diversion will be offset by the discharge from the well to Iman Lake. No additional withdrawal, beyond the amount added to the lake from the well, is authorized."

The rate of diversion is limited to a maximum of 1.3 cubic feet per second. However the diversion shall be decreased (or stopped), as necessary to assure a minimum flow of 4 cubic feet per second immediately downstream of the point of diversion.

"An approved staff gauge shall be installed in an appropriate position in Foster Creek, and maintained in working condition. Staff gauge readings shall be recorded weekly using a consistent methodology. An annual summary shall be transmitted to the Department of Ecology's Southwest Regional Office annually, during the month of February, or more frequently if requested by the Department."

"The certificate holder shall is stall and maintain an exproved measuring device at the pumping station in accordance with RCW 90.03.360, and WAC 508-64-020 through -0.40.

The amount of water granted is a maximum limit that shall not be exceeded. The water user shall be entitled only to that amount of water within the specified limit that is beneficially used, and that amount of water required for the actual crop grown on the number of acres and place of use specified.

Water available under this authorization may not provide a continual supply throughout each irrigation season.

This certificate is issued subject to Washington Department of Fish and Wildlife hydraulic project approval.
