LIMITED POWER OF ATTORNEY

IMC MORTGAGE COMPANY, a Florida corporation, ("IMC"), hereby appoints FAIRBANKS P. CAPITAL CORP., a Utah corporation with a mailing address of P.O. Box 65250, Salt Lake City, Utah Fairbank 84165-0250 ("Fairbanks"), acting by and through Fairbanks' authorized agents, employees, or representatives, as IMC's duly authorized attorney-in-fact to take the following designated actions with respect to any home equity loan (each, a "Loan") held by the trust established under each Pooling and Servicing Agreement (each, a "Pooling and Servicing Agreement") identified in Exhibit A hereto:

- endorse the name of IMC upon all checks, drafts, notes, powers and other forms of exchange received in payment of, or tendered in connection with, the Loan;
- execute on behalf of IMC any assignments, documents or instruments necessary to assign, convey, or otherwise transfer an interest in the Loan to and/or from IMC; and
- execute on behalf of IMC any documents necessary to carry out foreclosure of any mortgaged property securing the Loan.

This limited power of attorney is not intended to enlarge or otherwise modify any powers granted under a Pooling and Servicing Agreement or to allow Fairbanks to take any action with respect to a Loan not authorized by the applicable Pooling and Servicing Agreement.

This Limited Power of Attorney shall be effective as of the date of execution hereof and shall continue in full force and effect until terminated by IMC by written notice to Fairbanks mailed to the address above. Otherwise, this Limited Power of Attorney shall remain in effect until Fairbanks ceases to act as servicer under any Pooling and Servicing Agreement.
