No. 37 in Sec. 27 and 34, T. 3 N., R. 8 E.W.M., lying southerly of the Spokane, Portland and Seattle Railroad right of way; AND beginning at the intersection of the west line of the Jos. Robbins D.L.C. No. 38 with the south line of Sec. 27, T. 3 N., R. 8 E.W.M.; thence north along the west line of the south 1320 feet; thence east 660 feet; thence south 1320 feet; thence south 1320 feet; thence west 660 feet to the point of beginning; EXCEPT the following described tracts of land:

beginning at the intersection of the southeasterly line of the Berge Road with the east line of the tract first above described 474 feet south of the northeast corner thereof; thence south 264 feet; thence west 186 feet, more or less, to intersection with the south-easterly line of said Berge Road; thence northeasterly along the Berge Road to point of beginning;

AND EXCEPT commencing at an iron stake set on the northerly line of State Highway No. 8 660 feet east of the west line of Jos.
