## RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, that certain mortgage dated August 1, 1942, made by LEWIS A. LARSEN and CLOVER M. LARSEN, husband and wife, mortgagers, to HENRY BOLLE, ELLA HOOKER, and HENRY RICHARD BOLLE, mortgagers, and recorded on May 2, 1944, at Page 156 of Book "W" of Mortgages, Records of Skamania County, Washington, on the lands hereinafter described, together with the debt thereby secured, is fully paid, satisfied and discharged:

BEGINNING at Corner 1, the northeast corner of said south half of the northeast quarter of the southeast quarter  $(S_2^{\frac{1}{2}} N E_4^{\frac{1}{4}} S E_4^{\frac{1}{4}})$ , a point from which the quarter corner common to said Section 21 and Section 22 bears north  $00^{\circ}$  06' east 9.98 chains distant; thence with the boundary line common to said Sections 21 and 22, south  $00^{\circ}$  06' west 9.39 chains to Corner 2, a point in the intersection of the said boundary line common to said Sections 21 and 22 with the north right-of-way boundary of Highway U. S. 830 (washington State Road No. 8); thence south  $82^{\circ}$  52' west, passing within said south half of the northeast quarter of the southeast quarter  $(S_2^{\frac{1}{2}} N E_4^{\frac{1}{4}} S E_4^{\frac{1}{4}})$ , with said north boundary of said Highway U. S. 830 (Washington State Highway No. 8), 4.07 chains to Corner 3; thence leaving said north right-of-way boundary of said highway, north  $00^{\circ}$  06' east 9.34 chains to Corner 1, a point in the north boundary of said south half of the northeast quarter of the southeast quarter  $(S_2^{\frac{1}{2}} N E_4^{\frac{1}{4}} S E_4^{\frac{1}{4}})$ , thence with the aforesaid north boundary of said south half of the northeast quarter of the southeast quarter  $(S_2^{\frac{1}{2}} N E_4^{\frac{1}{4}} S E_4^{\frac{1}{4}})$ , thence with the aforesaid north boundary of said south half of the northeast quarter of the southeast quarter  $(S_2^{\frac{1}{2}} N E_4^{\frac{1}{4}} S E_4^{\frac{1}{4}})$ , north 89° 32' east 4.04 chains to the place of BEGINNING, in Skamania County, Washington.
