SHERIFF'S DEED

This Indenture, Made this 15th day of June, 1938, between M. T. Borden, Sheriff of the County of Skamania, State of Washington, party of the first part, and The Federal Land Bank of Spokane, a corporation, party of the second part, Witnesseth:
