I, Vernon R. Carney, being first duly sworn, depose and say: That I am one of the grantors in that certain deed under date of Febraury 28, 1938, wherein the United States of America was granted the SE $\frac{1}{4}$  NE $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 26, Township 3 North, Range 9 East of the Willamette Meridian, Skamania County, Washington, subject to right of way 40 feet in width over and across said property, in favor of Skamania County, Washington, for a county road. That said land is not subject to any vested or accrued water rights for any purposes in favor of the United States of America or any third persons, nor is said land subject to the vested right of any proprietor of a vein or lode to extract and remove ore therefrom, nor is said land subject to any vested rights of way for ditches or canals constructed by authority of the United States. I further say that no easements are existent which are used by third persons in connection with vested and accrued water rights that affect the lands which were granted the United States of America, as above mentioned. I also say that no person or parties are in possession of said lands, except the grantors in the above mentioned deed. That there are no questions of survey or boundary disputes affecting the said land. That there are no mechanic's lien claims existent, not shown of record, that affect said land.

That I make this affidavit for the purpose of meeting certain objections as pointed out in the Attorney General's opinion under date of May 6, 1938.
