KNOW ALL MEN BY THESE PRESENTS, That C. C. Hon and Daisy Hon his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Forty and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land being all that portion of the south six and one-half acres of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 36, Township 3 North, Range 7 $\frac{1}{2}$ E.W.M. southeasterly of an existing county road that lies southeastwardly from a line parallel with and distant 150 feet northwestwardly (measured at right angles) from the center line of said highway,

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval August 24th, 1937.

TO HAVE AND TO HOLD the same, unto the State of Washington forever.

It is understood and agreed that the delivery of this deed is hereby tendered and such tender kept good until revoked but that the terms and obligations hereof shall not become binding upon the State of Washington unless and until accepted and approved hereon in writing for the State of Washington, Department of Highways, by the Right of Way Engineer.
