NOW THEREFORE, the parties of the first part hereby agree that they will furnish water to the dwelling house upon the plot of land described in deed of even date herewith for the sum of One (\$1.00) Dollar per month.

other lots in the vicinity of said tract of land and will furnish water to said other tract of land in accordance with the rules and regulations of the Public Service Commission and the laws of the State of Washington. That they will take such steps as necessary to conform with the laws, rules and regulations for the furnishing of water to the property aforesaid and will file with the Public Service Commission, a schedule of rates in which the base rate for such service to each dwelling shall not exceed the sum of One (\$1.00) Dollar per month. The said base rate to provide for the use of not to exceed three outlets or a monthly consumption of not to exceed 7500 gallons and provided further that such base rate shall be subject to amendment in accordance with the laws and regulations provided by the Public Service Commission.

The said Public Utilities shall be so formed as to be available for water service to the party of the second part and whensso established this agreement shall be terminated.
