does hereby REMISE, RELEASE and QUITCLAIM, unto Lizzie G. Packard, grantee, all right  
title and interest in and to the following described real property in Skamania County,  
Washington, to-wit:

All that portion of the Southwest quarter of the Northwest quarter of Section 14  
Tp. 3 N.R. 10 E.W.M., which lies West of the center of the road leading to the  
Electric Power Plant of the Northwestern Electric Company on the White Salmon River,  
subjecto to said road easement as located and traveled and excepting therefrom a st-  
rip of land 100 feet in width along the South side of said land conveyed to Olaf  
C. Larsen by Christian E. Larsen et ux. It is the intention of the grantor to  
hereby agree to convey all that portion of the said Southwest quarter of the North-
