Underwood Irrigation Dist. by Rec. to W. E. Buell

RECEIVER'S DEED

THIS INDENTURE, Made this 22 day of August, 1938, by and between Cedric Miller, Receiver of the Underwood Irrigation District of Skamania County, Washington, and W. E. Buell,

WITNESSETH: That whereas the Underwood Irrigation District has heretofore acquired certain pieces and parcels of real property heretofore described by means of foreclosure of delinquent assessments, and has received deeds therefor, and

Whereas a proceeding has been instituted in the Superior Court of Skamania County, Washington, and in said proceeding it has been ordered that the Underwood Irrigation District be dissolved, and the property deeded to the bondholders in exchange for their bonds.

NOW, THEREFORE, and pursuant to the order of the Superior Court of the State of Washington for Skamania County, and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations, lawful money of the United States, to me in hand paid, the receipt whereof is hereby acknowledged, I the undersigned Receiver of the Underwood Irrigation District, do hereby grant, bargain, sell, and convey to W. E. Buell, his heirs, and assigns the following described real property located in Skamania County, Washington, to-wit;

The N $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ and the N $\frac{1}{2}$ of the S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22, Tp 3 N, R 10 E, containing 30.29 acres.

And also, commencing at a point 261 ft W of the SE corner Section 15, Tp 3 N, R 10 E, W.M., thence N 209 ft., thence W 208 ft, thence N 209 ft, thence E 319 ft, thence N 904.9 ft, thence W 1145.4 ft, thence S 1317 ft, thence E to the point of beginning in Section 15, Tp 3 N, R 10 E, containing 33.31 acres.

And also, the N $\frac{1}{2}$ of the SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 22, Tp 3 N, R 10 E, containing 20.21 acres.

And also, the S $\frac{1}{2}$ of the S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 22, Tp. 3 N, R 10 E. W.M. containing 10.10 acres.

And also, the S $\frac{1}{2}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22, Tp 3 N, R 10 E, containing 20.18 acres.

And also, the SW $\frac{1}{4}$ NE $\frac{1}{4}$ and the N $\frac{1}{2}$ of Lots 3 and 4, Section 22, Tp 3 N, R. 10 E, containing 66.62 acres.

And also, the N $\frac{1}{2}$ of the S $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$, and the S $\frac{1}{2}$ of the S $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$, except beginning at the SW corner of the above property, thence N 10 rods, thence E 20 rods, thence S 10 rods, thence W to the place of beginning, for road purposes, in Section 15, Tp 3 N, R. 10 E., W.M., all containing 18.16 acres.

And also, the NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22, Tp 3 N, R 10 E, except one acre in the NW portion thereof heretofore deeded to School District No. 17 of Skamania County, the balance containing 39.39 acres.
