

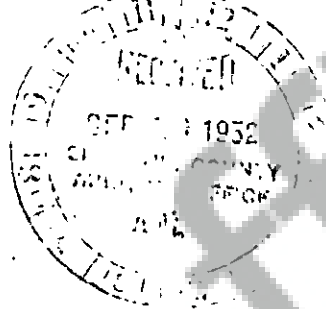
Partial Release of Mortgage

KNOW ALL MEN BY THESE PRESENTS, That

Camas Branch, The National Bank of Commerce of Seattle

to secure payment of the sum of

from the lien of the said mortgage the following described portion of the mortgaged premises, situate in the

Beginning at a point 40 rods West of the center post of Section 36,  
Township 3 North, Range 7 E.W.M.; thence South 990 feet; thence South  
27° East 330 feet to a point on the South side of Rock Creek Springs Road,  
said point being the initial point of the tract herein described; thence  
South 10° East 75 feet; thence South 62°04' East 125 feet; thence North  
10° West 75 feet to intersection with the Southerly line of said road;  
thence following the Southerly line of the said road in a Northwesterly  
direction 125-feet more or less, to the point of beginning.
