That the parties of the first part, in consideration of the sum of Five Dollars, (actual consideration being less than One Hundred Dollars), do hereby REMISE, RELEASE and forever QUITCLAIM unto the party of the second part, all their right, title and interest in and to the following described real property in Skamania County, Washington, to-wit:

The East half of the South East Quarter of Section Three (3), in Township one (1) North of Range five (5) East of Willamette Meridian, containing eighty acres more or less.

Also, commencing at the section corner to Sections 2, 3, 10 and 11 Township one (1) North of Range five (5) East of Willamette Meridian, thence North along section line 14.40 chains, thence East 1.43 chains, thence South 14.40 chains; thence west 1.43 chains to the place of beginning, containing 2.06 acres, more or less.
