That Anthony Doherty died on or about the 14th day of January, 1910, leaving as his sole estate the farm property described as Northwest Quarter of Section Twenty-nine, Town-ship Two North of Range Five East of Willamette Meridian, which passed upon his death to Mary Doherty by virtue of a community property agreement recorded at Page 58, Book "F" of Miscellaneous Records of Skamania County, Washington. That the value of the said property was less than the statutory exemption allowed to widows under the law relating to inheritance tax at the time, to-wit; of the value of Three Thousand Dollars or thereabouts and no inheritance tax became due or payable thereon.

That the only children and heirs at law of Anthony Doherty and/or Mary Doherty were the following: Mary Doherty, Margarite Doherty and Anna Doherty, daughters, and Peter Doherty and John Doherty, sons. That by inadvertence an error the Final Report and Decree of Distribution in the matter of the estate of Mary Doherty, deceased, names Al Doherty, a son, as one of the heirs at law of said Mary Doherty. There never was any such person as Al Doherty, son of Mary Doherty and Anthony Doherty. The statement is a typeographical error and intended for Anna Doherty, a daughter, who then resided at Portland, Oregon.

At the date the said Final Report was filed and the date of settlement of the estate and of the Order of Distribution thereon, all of the said children were living, over the age of twenty-one years and no incompetent.
