For and in consideration of the sum of One Hundred and Twenty-five Dollars, to them in hand paid, receipt whereof being hereby acknowledged, and other valuable considerations hereinafter fully set forth, have given and granted, and do hereby GIVE and GRANT unto the State of Washington the perpetual right to the use of the waters of a certain spring located near the northeasterly corner of said Lot 2, Section 30, Township 3 North, Range 10 E. W. M. said county and state, also a perpetual easement for a right of way for a one inch pipe line leading from said spring to the northwesterly right of way line of said Primary State Highway No. 8, and to maintain the same, as shown on map attached hereto and made a part hereof.

As a further consideration and in consideration of the foregoing the State of Washington hereby agrees to construct at the said spring a concrete reservoir with a suitable cover thereon, having an eight inch overflow pipe leading therefrom and extending therefrom a distance of 18 inches and on whichever side of said reservoir it shall be mutually agreed upon.
