I, Mary V. Lane, being first duly sworn upon oath, depose and say:

That Isabella Underwood was my half-sister and a daughter of Ellen Underwood by a former husband and that I am the daughter of Amos Underwood and Ellen Underwood, both deceased, and am familiar with the proceedings probating their respective estates in Skamania County, Washington.

That as the sole and only heir at law of Amos Underwood, I inherited a one-half interest in the hereinafter described property and as one of the heirs at law of Ellen Underwood, I inherited an undivided one-half interest in her community interest in the hereinafter described property and that said Isabella Underwood inherited the other onehalf interest of said community. That I am also familiar with that certain deed executed by Isabella Underwood to me under date of September 3, 1919 and recorded in Book "R" of Deed Records of Skamania County, Washington, at page 234. That in and by said deed it was intended to convey to me all the fight, title and interest of said Isabella Underwood in the real property so inherited by her and that in said deed the second southeast bearing of the 38.67-acre tract, being a part of the W2 of Lot 1, Section 23, Township 3 North, Range 10 East of the Willamette Meridian, was erroneously given as "thence along said line south 84° E 3387.66 feet to the southeast corner" instead of the "East 387.66 feet to the southeast corner", and that the lots therein described as being in Block 2 of the Town of Underwood should have been described as Block 2, First Addition to Underwood. That there is no Block 2 in the Town of Underwood, but that said Block 2 is frequently described as being in said Town, instead of First Addition to said Town.

That upon receipt of the deed I entered into full possession of the property intended to have been so conveyed, being a part of the W_2 of said Lot 1, Section 23, and Lots 1, 2, 3, 4, 6, 8, 9 and 10, Block 2, First Addition to Underwood, and from the date of said deed to the present time I and my successors in interest have been in the
