Florence Kollock Crooker to Joseph Henry Crooker et al

Know all men by these presents That I, Florence Kollock Crooker of Amherst in the County of Hampshire and the Commonwealth of Massachusetts, being of sound and disposing mind and memory, do make this last will and testament, hereby revoking any and all previous wills by me at any time heretofore made. After the payment of all my just debts and funeral charges, I give, devise and bequeath as follows:

First: I nominate and appoint my husband, Joseph Henry Crooker to be the sole executor of this my last will and testament and direct that sureties be not required of him on his official bond. I also give to him full power and authority to sell and convey as executor any part of all my real estate and personal property and no purchaser shall be answerable for the application of the purchase money derived from such sale; also to invest, reinvest and change investments as often as said executor may deem advisable.

Second: I order and direct my said Executor to deliver to my brother William M. Kollock, the sum of three hundred dollars (\$300.00) if living at the time of my decease.

Third: I order and direct my said executor to deliver to my brother, George C. Kollock the sum of three hundred dollars (\$300.00) if living at the time of my decease.

Fourth: I give, devise and bequeath to my said husband, Joseph Henry Crooker, the use, income and improvement of all the rest and residue of my estate, real, personal and mixed wheresoever and however situated during his natural life, with full power as executor to use and spend any part or the whole of the principal and income thereof for his comfortable support and maintenance said Executor to be the sole judge thereof.

Fifth: Upon the decease of my said husband Joseph Henry Crooker I give, devise and bequeath all the rest and residue of my estate in equal parts, to my two brothers if then living namely; the aforesaid William M. Kollock and George C. Kollock; but if only one is then living at the time of my decease he shall receive the rest and residue of my estate.

In witness whereof, I, the said Florence Kollock Crooker have hereunto set my hand and seal this fourteenth day of May in the year of our Lord one thousand nine hundred and eighteen.
