Lowe and Hilda Lowe, his wife, and Wilma Lowe (now Wilma Kuepfer) in consideration of the sum of One Dollar and the benefits to us do hereby Grant and Dedicate to the public the following real property in Skamania County, Washington, for street purposes, to-wit:

n Beginning at a point on the North line of State Highway #8, 1474 feet West of the line between Sections 21 and 22, Township 2 North, Range 7 East of Willamette Meridian, thence North 290 feet, thence West 25 feet, thence to the North line of State Highway #8, thence easterly along the north line of State Highway #8 to point of beginning.

To Have and To Hold unto the public so land as the same shall be used as street purposes and upon vacation of the same to revert to the property adjacent thereto in the same manner as property vacated under formal dedication.

It is the intent of the parties hereto that the land above described shall become part and parcel of the public street within the Town of North Bonneville known as Lowe Street subject to the same rights and privileges of control therein by the Town of North Bonneville as though formally dedicated in the manner provided by law.
