Administrator's Deed.

This Indenture, made the 20th day of March, 1939, at the Town of Stevenson, County of Skamania, State of Washington, by and between M. W. Beck, the duly appointed, qualified and acting Administrator of the Estate of P. S. C. Wills, deceased, late of the town and county aforesaid, the grantor; and William Warfield, the grantee, witnesseth:

That Whereas, during the lifetime of P. S. C. Wills, now deceased, the said P. S. C. Wills made and entered into a contract between himself and the grantee herein, whereby the decedent agreed to sell and the grantee agreed to buy certain property, hereinafter described;

And Whereas the total consideration for said contract was received by decedent during his lifetime;

And Whereas the Superior Court of the State of Washington in and for Skamania County, by an order made and entered this 20th day of March, 1939, upon due proof authorized and directed the grantor herein to execute and deliver to the grantee that
