Tom Combs to Ida M. Combs.

This Agreement, made and entered into by and between Tom Combs, party of the first part and Ida M. Combs, party of the second part, witnesseth:

Whereas, the parties hereto are husband and wife and are the owners of certain community property within the State of Washington, and

Whereas, the parties hereto desire to, and do hereby mutually agree as to the disposition of said community property upon the death of either.

Now Therefore, it is agreed by and between the parties hereto that all community property, both real and personal, now owned, held or possessed by them or which shall hereafter be acquired by them as community property, shall upon the death of either party immediately vest in and become the sole, separate and absolute property of the survivor, subject however to the following conditions to-wit:

That during the life time of said survivor she or he shall have the full rights, power and authority to the use, possession and enjoyment of said property, to manage, control, mortgage, convey or otherwise dispose of the same and to execute and deliver such agreements in writing, deeds, mortgages or contracts as may be necessary to carry out the power hereby confirmed or to vest in the vendee the full and absolute fee simple title to said real property or the absolute ownership of said personal property without necessity for accounting to any person or persons, whomsoever, for the proceeds of such sale or transaction but in case any of said community property shall remain the ownership of said survivor at the time of his death a one-half interest shall
