The said water main has existed across said properties without any substantial change in location during a period of more than twenty years prior to 1937. The only change made during said period was a re-location over the property belonging to Floyd McKelvey about 1929 or 1930. During all this time the Town of Stevenson and its predecessor in interest has held the peaceful possession of said water main and the easements upon which it is located under claim of right and title thereto; said possession has been open and no torious and has not been questioned by any person whomsoever.

Raymond C. Sly, being first duly sworn, says: I am a citizen of the United States over the age of twenty-one years and an attorney at Law, practicing law in the Town of Stevenson, Washington. Since previous to 1930 I have acted as attorney for the Town of Stevenson and the water department thereof and previous to 1930 was for many years attorney for Stevenson later and Improvement Company, a corporation. I am familiar with the location of the water main feeding the water system now owned by the Town of Stevenson from the source of supply known as the Learned Springs in Section 2 Tp. 2 N. R. 7 E. W. M. as it existed prior to the time the water of the Columbia River was raised by closing the gates of the Bonneville Dame.

The said water main was originally laid by E. A. Learned, then owner of the water system supplying the Town of Stevenson, about the year 1913. At that time the said E. A. Learned was the owner of a portion of the property described in the Flowage Easement from Floyd McKelvey to United States of America and I am certain that he acquired by purchase the easements for said pipe lines over other property, now affected by the backwater of the Bonneville Dam at the time but the conveyances to him have not been placed of record.

At about that time E. A. Learned and Bertha Learned, his wife, acquired all the capital stock of the Stevenson Mater and Improvement Company.
