Section 1: That the West 40 feet of Columbia Street from the North line of Second Street to the South line of Vancouver Avenue in Riverview Addition to the Town of Stevenson, as shown by the official plat of said addition in the office of the County Auditor of Skamania County, Washington, be and the same is hereby vacated.
