## Parcel No. 3

All that portion of the B. B. Bishop Donation Land Claim No. 39 in Sections 20 and 21, T. 2 N., R. 7 E., W.M., lying north of the northerly right-of-way line of the Washington State Evergreen Highway and south and west of the center line of the Greenleaf Slough; said tract being more particularly described as follows: Beginning at a point which is the intersection of the west line of the B. B. Bishop Donation Land Claim No. 39 with the northerly right-of-way line of the present Washington State Evergreen Highway, said point being 230.48 feet north and 4.06 feet east of the angle corner on the west line of the said B.B.Bishop Donation Land Claim No. 39, said corner being marked by a U. S. E. D. concrete monument; thence along the northerly right-of-way line of the Washington State Evergreen Highway to the intersection of the northerly right-of-way line of the said Washington State Evergreen Highway with the center line of the Greenleaf Slough; thence down the center line of the Greenleaf Slough along the meander line of said center line as follows: N. 39°43'50" W., a distance of 1142.02 feet; thence N. 52°01'00" W., a distance of 575.83 feet; thence S. 87°59'00" W., a distance of 400.00 feet; thence S. 63°02'00" W., a distance of 450.00 feet; thence S. 28°02'00" W., a distance of 113.13 feet to the intersection of the center line of the said Greenleaf Slough with the west line of the said B. B. Bishop Donation Land Claim No. 39; thence S. 1°00'35" W. along the west line of the said B. B. Bishop Donation Land Claim No. 39 a distance of 1718.53 feet, more or less, to the point of beginning, containing 58.2 acres, more or less, which land is also described in the declaration of taking filed in this proceeding, and is also delineated and shown in green on a certain map or plat thereof which is thereto attached and made a part of the declaration of taking, marked Schedule "A".

The ownerships involved in this taking, the number of acres which lie within the boundaries of the above described land/<sup>and</sup> the names of every owner of the same or any part thereof, so far as they can be ascertained from the public records or are known to the officials of the United States filing the petition, areas follows:
