gether with interest thereon from June 1, 1938 until paid at ten per cent per annum, and the taxes for the year 1938 in the sum of \$50.16, together with interest thereon from June 1, 1939 at ten per cent per annum that is, One hundred thirty and 20/100 (\$130.20) Dollars, unless paid prior thereto and unless defendants shall first pay the same.

It is further ordered and directed that the Clerk of this Court pay over to the said defendants Gust J. Melonas and Catherine Melonas, husband and wife, Steve Melonas and Mary Melonas, husband and wife, the sum of Seven Thousand Three Hundred Thirteen and 88/100 Dollars (\$7,313.88), together with interest thereon at the rate of 6 per cent per annum from December 22, 1937 until paid into the registry of this Court, less such sum as shall be necessary to pay taxes due and unpaid upon said property as aforesaid, that is, Seven Thousand Seven Hundred Seventy Nine and 76/100 (\$7,779.76) Dollars, said sum to be paid without any deductions for commission or poundage fees, taking a receipt therefor to be filed in said cause.

Now at this time, This cause coming on to be further heard and consideration thereof and the Court being duly advised, and it appearing to the Court that on July 19, 1937, which date the court finds to be the correct date instead of October 11, 1937 appearing in former judgment and stipulation, petitioner filed in the above entitled action a petition asking for the condemnation of a perpetual flowage easement over certain lands described therein, and that on May 3, 1938, a stipulation was entered into between the United States of America and defendant West Coast Power Company, a corporation, agreeing
